101	11th Cir. R. 27-1(a)	Proposal to change the title from “No Copies Required and Form of Motion” to “Form and Other Requirements.”
102	11th Cir. R. 27-1(a)(7)	New proposed subsection stating that unless the appellant is represented by other attorneys, a motion to withdraw as counsel for the appellant in a criminal or civil appeal stays the deadlines to file all required documents, including motions to proceed in forma pauperis, Transcript Order Forms, CIPs, and Civil Appeal Statements. The proposed revisions also note that the provision does not apply to motions to withdraw under <i>Anders v. California</i> .
174	11th Cir. R. 45-1(b) <u>Office to Be Open</u>	Proposal to replace the list of legal holidays with a reference to “the legal holidays listed in FRAP 45(a)(2).”
Add. 3, Page 17	Addendum Three, 11th Cir. JCDR 6.6 <u>Place of Filing</u>	Proposed revisions to allow complainants to file judicial complaints by email.
Add. 3, Page 17	Addendum Three, 11th Cir. JCDR 6.9 <u>Notification of Change of Address</u>	Proposal to require complainants to notify the Clerk’s Office of any changes to email or mailing addresses.
Add. 3, Page 31	Addendum Three, 11th Cir. JCDR 11.1 <u>Electronic Distribution of Materials</u>	Proposal to state that materials described in the rule may be sent to complainants electronically.
Add. 3, Page 41	Addendum Three, 11th Cir. JCDR 16.1 <u>Electronic Distribution of Materials</u>	Proposed new rule stating that materials described in the rule may be sent to complainants electronically.
