See 11th Cir. R. 46-7. NOTE: certificates of good standing issued by some state bars, e.g., the State Bar of Georgia, do not establish that an attorney is admitted to the highest court of a state.
- You must have a member of this Court's bar move for your admission on this application form unless you certify by checking the appropriate box that you do not know a current member of this Court's bar.
- Upon approval of your application, you must pay the non-refundable amount of \$239.00 (comprised of a \$199.00 national fee and a \$40.00 Eleventh Circuit fee) via PACER. Failure to pay the fee within 14 days of approval of your application will require that you submit a new application form.
