## How to File an Appearance of Counsel Form

An attorney filer should file an Appearance of Counsel Form at least 2 days prior to filing any other documents. The ECF system will not accept any other e-filings from an attorney filer until their Appearance of Counsel Form has been processed by the Case Administrator.

- 1) Complete and save the 'fillable' Appearance of Counsel form available on the Court's website at www.ca11.uscourts.gov.
- 2) Log in to CM/ECF.
- 3) From the Startup page, select the menu option 'Filing'.
- 4) The 'File a Document' screen will open.
- 5) In the 'File a Document' screen, enter the case number and press [Tab].
- 6) Click in the '**Type of Document**' field and begin typing the word 'appearance'.
- 7) Click 'Appearance of Counsel Form Filed' to select and click [Continue].
