The appellees' en banc brief is due within 30 days after the service of the last appellant's brief. The appellants' en banc reply brief, if any, is due within 21 days after the service of the last appellee's brief. This is the only notice you will receive regarding the due date for briefs and appendices. All parties must submit 10 briefs in paper to the clerk's office. Counsel is not required to submit the additional copies of the previously filed briefs. **NO EXTENSIONS WILL BE GRANTED.**

Brief Compliance Check Program

Oral argument will be held in Atlanta in June 2026. Each side will have 20 minutes for argument.
