THE STAFF ATTORNEY'S OFFICE: POSITION OVERVIEW

The Staff Attorney's Office serves the court at large rather than individual judges. Staff attorneys review case records and filings, conduct legal research, and draft bench memoranda and proposed opinions to assist the judges in the consideration and resolution of a wide variety of cases on appeal. Staff Attorneys develop expertise in civil and criminal procedure and in various areas of substantive law, including criminal, sentencing, immigration, employment discrimination, civil rights, habeas corpus, and Social Security. Additionally, a specialized team within the office assists the court in the initial review of all appeals for the purpose of determining appellate jurisdiction. Another specialized team presents substantive motions to the court, including motions for *in forma pauperis* status, certificates of appealability, transcripts at government expense, and withdrawal/substitution of counsel. Finally, our special appellate matters unit handles special projects from the court and tracks legal issues as they develop in the U.S. Supreme Court and the Eleventh Circuit.

THE STAFF ATTORNEY EXPERIENCE

The experience of serving as a staff attorney provides insight into how courts resolve cases; exposure to the documents, procedures, and processes of federal litigation; and the opportunity to further strengthen analytical skills and writing abilities. The legal skills and understanding of the judiciary that staff attorneys develop during their two-year terms serve them throughout their careers, regardless of their future area of practice. By helping the court fully understand the contours of cases and analyzing what issues are most critical, staff attorneys hone skills they will use in the future when they advise clients or argue cases as an advocate. Every day, staff attorneys see practicing attorneys in action by reading briefs or observing oral arguments. Through this process, staff attorneys learn where advocates shine and where they sometimes fail, and they apply these lessons in their own future careers.

In addition, the work of a staff attorney is a public service. While the workload of the office is heavy and the responsibilities of the job are significant, the service is rewarding because our work helps to ensure that the wheels of justice turn smoothly, that the litigants are treated fairly, and that their cases are carefully considered. In criminal appeals, our input might mean the difference between someone being punished or walking free. In civil appeals, important rights, both financial and constitutional, are often at stake.

Finally, the relationships staff attorneys develop during and after their tenure with the Eleventh Circuit are lasting ones. Because the Staff Attorney's Office recruits attorneys from across the United States, many of whom join us without knowing anyone in Atlanta, staff attorneys make a concerted effort to be inclusive and to organize frequent outside social activities. This not only leads to friendships forged easily and quickly, but helps create an atmosphere with a healthy balance between work and personal life. In addition, because of the two-year term of service, we have alumni across the country, so staff attorneys have a built-in professional network, and friendships based on the shared experience here continue to develop even after attorneys leave the office.

REQUIRED QUALIFICATIONS

- Juris Doctor degree from a law school of recognized standing at the time of appointment
- Outstanding academic credentials and exceptional analytical, research, writing, and editing skills
- Proficiency in computer-assisted research, Windows, and Word
- Strong communication skills and attention to detail
- Law journal, moot court, or equivalent significant writing and editing experience strongly preferred

Third-year and rising third-year law students, recent law school graduates, and experienced attorneys are encouraged to apply. Federal court experience and/or expertise in federal appellate, civil, and criminal law are not required, nor are ties to the southeast.

Applicants must include their most recent law school class rank and/or percentile available or include a brief explanation as to why this information is unavailable.

CONDITIONS OF EMPLOYMENT

Applicants must be U.S. citizens or must be eligible to work for the federal government.

Selected candidates will be subject to a background check and favorable suitability determination as a condition of employment.

Employees are required to use the Electronic Fund Transfer (EFT) for payroll deposit.
